Minutes of the Binfield Heath Parish Council Meeting held on Monday July 20th 2020 at 5 pm by Zoom

Meeting of the Recreation Ground Charities & Allotment for the Labouring Poor Charity

15/20 Recreation Ground

15.01/20 After a member of the public was seen cutting the tape within hours of its application, the area was reopened. Signs indicating that users were responsible for their wellbeing and that of their children were put on all access points. Advice was given to use sanitiser before and after using the equipment.

15.02/20 A resident has volunteered to lock and unlock the Recreation Ground on a daily basis to limit the antisocial behaviour seen over the last year or so.

15.03/20 Different types of football posts have been considered by the Trustees. A movable and lockable set has been selected. The Chairman will discuss the choice with the interested boys before it is ordered.

15.04/20 Some grass reseeded is necessary before the goalposts can return to their original position. Topsoil has been ordered and will be delivered as soon as possible. **(Clerk to contact Pricketts)**
